#### Part 2 - Creating an Express Entry Profile

### **Application Requirements:**

- If the individual does not have an offer of arranged employment non-LMIA (Labor Market Impact Assessment) supported work permit they are required to register with the national job bank. National job bank registration is a mandatory part of the process
- Candidates can apply using the combination of GCkey and the registration number from their Express Entry profile
- Currently, the job-matching between the candidates' profiles in the job bank and the employers is not fully functioning
  - > This function should be available towards the end of the year 2015
  - ➤ In the future, registered individuals may receive information from employers who are interested in their profile
- If the individual meets the minimum entry criteria for the express entry and one of the underlying economic programs, they will be admitted into the Express Entry pool
- If they are one of the highest-ranking candidates in the express entry pool at the time when there is an invitation round, they will receive an electronic invitation to apply
  - Comes in the MyCIC
  - After receiving the invitation, the candidate has 60 days to apply for permanent residency

#### **Creation of an Express Entry Profile:**

This stage provides an opportunity for CIC to evaluate the applicant's background in terms of eligibility for the specific program they are applying for, and assign the comprehensive ranking scores

- Required information:
  - Basic biographic information about the individual and their spouse
  - Information from their Language Proficiency Test
  - Education credentials
    - ➤ Needed if studied outside of Canada and would like to receive ranking points for it, or be considered under the Federal Skilled Worker Program
    - Assessed by one of the three agencies designated for this process

- Each agency has variations in the assessment costs and processes
- Note: there are specific education credential agencies required for the physicians and pharmacists: the Medical College and the College for Pharmacists

# • Employment history

- ➤ At the profile stage only, can limit the employment history to the ones relevant to qualify for the underlying stream and to gain the points for the comprehensive ranking system
- At this stage only, can leave out the spousal employment history if the points are not required for the comprehensive ranking system
- > Note: the candidate will later be requested to provide employer support letters for every job listed in the employment experience
- Complete the job registration
  - ➤ Once the profile is created, the candidate only has 30 days to complete the job bank registration; otherwise the profile will go inactive

# **Express Entry Pool Applications:**

- Currently, includes skilled workers already in Canada who:
  - have arranged employment, a provincial nomination certificate or Canadian work experience
- Would potentially include skilled workers outside of Canada who:
  - have arranged employment
  - have registered with the job bank and have met the language proficiency and education assessment
  - have skilled traits within provincial certification and/or a job offer
- Approximately 1,500 people are entering into the pool each week
  - Can expect the number of potential applicants to grow over the course of the next couple of years

## Evaluation (July, 2015):

- Approximately 100,000 people have created profiles for the Express Entry
  - Almost half of the applications (48,000) was found ineligible

- Approximately 4,300 applications were pending based on job bank registration
- > Approximately 6,400 applications withdrawn
- Approximately 12,000 invitations to apply were issued
  - Approximately 7,500 applications were submitted online; about 6,050 were approved through to the landing phase
  - > The remaining applications were abandoned, declined or considered incomplete
  - > Approximately 41,000 active profiles in the Express Entry pool
  - ➤ Bulk of the numbers in the pool are sitting between 300 and just under 450 range
